Existing Construction

Ductless Mini Split Heat Pump System (must be Pre-Approved)

One rebate per existing residence.

- **Single Family Site Built homes** **\$ 800.00**
 Must have pre-existing baseboard, electric wall heat.
 The Heating Seasonal Performance Factor (HSPH) requirement is 9.0 for single head systems and 8.0 for multi-head systems.
- **Manufactured Homes or Single Family Site Built homes** **\$1,000.00**
 Must have electric forced air furnace to qualify.
 The (HSPH) Heating Seasonal Performance Factor requirement is 9.0 for single head systems and 8.0 for multi-head systems.

Ductless heat pump must be installed by a licensed contractor who is on the NW Ductless Heat Pump Project certified list. Located at www.goingductless.com.

The ductless heat pump must be listed on the Bonneville Power Administration qualified ductless heat pump list. Located at www.bpa.gov/ResHVAC.

Air Source Heat Pump

\$1,400.00

- Air source heat pump conversion program- site built or manufactured home must have an electric forced air furnace.
- The Heating Seasonal Performance Factor (HSPF) rating must be 9.0 or higher and a seasonal Energy Efficiency Ratio (SEER) rating of 14 or higher. It must be AHRI tested and certified.
- PTCS heat pump commissioning tests are required on all units.
- Duct Sealing is required when 30% or more of duct work is located in unconditioned space and accessible.
- Mason/Jefferson County Mechanical permits are required for site-built homes.
- Washington State Labor & Industries (L&I) electrical are required for site-built and manufactured homes
- Work must be performed by a PTCS certified technician.
