PUBLIC COMMENT:

BUSINESS AGENDA:

Marcus Perry, BPA

Marcus Perry presented the new rate case for the biennium 2017-2018. The new rates went out in July to be effective 10/1/17. Overall average power increase is 5.4%. A few things are driving up BPA's costs including less load, which means there are fewer customers to spread the costs amongst resulting in higher rates. The transfer service cost is also an increase driver as well as surplus secondary sales prices being very low. BPA has a 1% reserves policy, which when they fall below that, they must institute a CRAC, to ensure that reserves are properly funded. BPA almost had a CRAC this year. Ron asked about the Residential Exchange and organizational issues at BPA. He doesn't understand why things aren't being streamlined and are taking so long. He doesn't believe BPA operations are sustainable the way they are going. The price of power has doubled since he's been a commissioner. Marcus said these

concerns of Ron's are all being put on the agenda for discussion at the Focus 2028 meeting. The 6% total impact to Mason PUD 1 is higher than average. This is largely in part to a reduction in our Low Density Discount and an increase in our power costs. There will also be a spill surcharge assigned to all customers to pay for lost revenue for the spill, which was mandated by federal district court. The surcharge will be enacted in the Spring of 2018. The transmission rate impact is 0.84%, or approximately \$2,200.

Resolution No. 1092- Designating RUS Certifiers

This resolution authorizes the manager to appoint someone to do the RUS reporting, in this case Katie Arnold.

Ron made a motion to adopt Resolution No. 1092 as presented; Mike seconded the motion. It passed unanimously.

Establish Date for Electric Rate Hearing

The board decided to hold a rate workshop for the commission at 11:00 a.m. on Tuesday, September 12th with a public hearing on the new proposed electric rate schedule to follow at 1:00 p.m. The rate schedule will be on the agenda for approval at the business meeting following the public hearing.
