Description of Proposal

This is a financial, policy, operational, maintenance and organizational planning document. This planning document goes over the consolidation feasibility of Mason PUD 1 Union water systems (Union, Union Ridge, Highland Park, Vuecrest, Alderbrook Water Co. and Hood Canal water systems).

This planning document will allow Mason County PUD 1 to move forward with consolidating these water systems over the next 20 years. The plan identifies improvements necessary to meet projected water demands within the consolidated water system service area. Planned projects include interties to interconnect the systems and more reliably provide water service to this area.
