#### NOTICE IS HEREBY GIVEN THAT PUBLIC UTILITY DISTRICT No. 1 OF MASON COUNTY, WASHINGTON,

does hereby invite bids from qualified, responsible bidders specializing in Fence Installation.

#### **PRE-BID WALK THROUGH -**

The pre-bid walk through will be held on January 5, 2021 at 10:00 a.m. at the District office. The facilities are locked so our Director of Operations will meet everyone in the parking area. Potential bidders shall follow all COVID-19 regulations and wear masks and stay distanced. The walk through is not required but highly recommended. We will not provide individual information or Q&A outside of the walk through.

#### **SUBMISSION DEADLINE:**

Bids must be submitted electronically to Julie Gray, at julieg@mason-pud1.org, no later than Tuesday, January 12, 2021 at 4:00 p.m. The District's electronic email time clock will be the official date/time stamp. Bids received after deadline will not be considered.

#### **SCOPE OF WORK:**

Fence the perimeter of PUD 1 property and install appropriate gates with 8' cyclone fencing. Property address is 21971 N US HWY 101 Shelton, WA 98584. Approximate 3,600 linear feet.

CONTRACTOR WILL:

- Supply all materials to properly install fencing and gates.
- Begin work no later than February 1, 2021 and complete work no later than March 31, 2021


