Authorize the GM to sign the Amended ARPA contract with Mason County for Arrearages – Jack made a motion to authorize the GM to sign the amended ARPA contract with Mason County for the transfer of \$100,000 of arrearages funding to the fiber project and retain \$25,000 in total arrearages support. Ron seconded the motion. Motion carried.

Authorize the GM to sign a 3 year contract with Big Blue Landscaping – Jack made a motion to authorize the GM to sign a three year contract with Big Blue Landscaping. Ron seconded the motion. Motion carried.

Staff Reports -

General Manager – Kristin reported that Mike Sheetz had a meeting with representatives at AGYC and she put together a report to address their questions and the follow up questions that Mike brought back from the meeting. She reviewed the report with the commission and stated that Mike would forward it to AGYC's general manager. She reported that the wildfire bill had passed 49-0 in the house and was up for a vote in the senate, so it is a good thing that the PUD is ahead of the curve on getting a plan approved and in place. She reported that the Eels Hill rebuild was finished and waiting on county approval. She reported that HCC's boring machine broke again on the Colony Surf project, so we ended up trenching the rest of the hill to complete that underground section. Jared Hanson is starting on February 28 with HCC to lay fiber in divisions 5 & 6 and the power crew will replace underground during this time while the ditches are open. She reported that the U.S. Forest Service wants a \$1 million dollar liability policy. Insurance is not available for this type of liability. She asked if they could reduce the amount due to the PUD's size and budget. She is still awaiting an answer. She reported that the logger should be ready to start with the clearing for the Jorstad substation easement in a month or so.

Director of Finance – Katie reported that she was made aware that Jefferson County's storm damage from November had been declared by FEMA. Most of PUD 1's storm damage for that event was in Jefferson County, so she was working to get a Request for Public Assistance submitted to FEMA for that storm damage reimbursement. She also gave an update on the status of the January 2022 storm, stating that the Mason County threshold is approximately \$269,000 to qualify for a FEMA declaration. She wasn't concerned with the county meeting that threshold since PUD 1's damages alone are over half a million dollars. It will be a while before we see funding since it still must go through the governor and then to the president for approval before FEMA we will reimburse for damages.

Water Resource Manager - Brandy reported that she had received an inquiry from a small water system owner off Webb Hill. The system has approximately 6 connections. She also reported that the mainline replacement on Blackberry Lane in Alderbrook should be finished in two weeks and when the water techs tie in the line there will be a water outage on Blackberry Lane and Blackberry Court. Customers will be notified of the outage ahead of time. She reported that the generator bids for Arcadia Estates and Bellwood water systems are due on February 28th. She also reported that the survey crew will be at Shadowood well site doing a topographic survey on either February 25 or 28. The HOA has been informed.
