Yes, this is a planning document that encompasses a well producing up to 60 Gallons/Min that feed customers and follows Department of Ecology, as well as Department of Health Standards. Mason County PUD 1 also manages the Water Use Efficiency of each system. Yes, most of the water is discharged to groundwater via septic systems and irrigation of lawns, gardens and other activities therefore recharging the aquifers. The total withdrawal of average annual demand is approximately 120 acre-feet and practically all water withdrawn will return to groundwater through one or more activities listed above.
