BUSINESS AGENDA:

March and 1st Quarter Financials – Katie reported that the gross revenue was \$1,316,329 for the month of March 2023 and gross expenditures were \$1,088,320 for the same month. She also reported that as of March 31, the PUD has \$685,766 in grant reimbursements outstanding for ongoing projects. For the quarterly budget review, she stated that we should be around 25% of the annual budget for both revenue and expenditures. All divisions are within that 25% range and on track with the budget.

Claim for Damages- Tabasinski– Rob Johnson had Federated Insurance do an investigation of the original claim made by Mr. and Mrs. Tabasinske. After reviewing the claim and the investigation findings of no fault or negligence by the PUD, staff made a recommendation to deny the claim. Mike made a motion to deny the claim for damages. Ron seconded the motion. Motion carried.

Update to the Mason County Hazard Mitigation Plan. – Kristin reported that Mason County is updating their Hazard Mitigation Plan, which PUD 1 has annexed into in previous years. The public comment portion is open and the board of county commissioners should adopt the plan in coming weeks.

Staff Reports -

General Manager – Kristin reported that George Caan, Executive Director of WPUDA is retiring. She reported that she received word that Senator Cantwell put \$1.5 million in her appropriations budget for the Jorstad substation. She reported that Rep. Travis Couture called to share the news that the PUD received over \$1.6 million for Viewcrest, Ripplewood and Agate Beach Phase 3 water projects. She reported that the PUD did not get the substation security grant. She also reported that the BPA outage over the past weekend was due to vandalism. She reported that the Mason County EDC is working on a \$20 million dollar RECOMPETE ACT application. If Mason County is selected, it is possible that the PUD would be eligible for \$2-3 million for the Manzanita water storage project. The PUD has had three positive COVID cases in the last week and she and Katie have reminded employees about COVID protocols and testing. The water and electric crew all re-certified their flagging cards at the last safety meeting.

District Treasurer – Katie reported that she was asked to present at the APPA National Conference in June, on how to apply and receive funding from FEMA for mitigation after disasters. She and Kristin are working on the power point presentation and are looking into having Washington Emergency

Management as a co-presenter so that attendees can hear from both perspectives on how to prepare successful applications.

Water Resource Manager – Brandy reported that the project at Alderbrook on E. Westward Way will be complete on Friday. Next week is National Drinking Water Week and the PUD will hand out water conservation kits over the counter for customers. She also reported earlier this week she, Katie, and James had the pre-construction meeting with DOH and the contractor regarding the Lake Arrowhead Manganese treatment.

Legal Counsel – None.

Correspondence – A letter to customers on Dark Rd. in Brinnon discussing activities in the PUD/HCC project staging area, comments on the Columbia River Treaty and comments to LNI on their Heat Exposure rulemaking were shared with the commission.
