#### **BUSINESS AGENDA:**

**July Financials**– Katie reported gross revenue was \$1,039,023 for the month of July 2023, with gross expenditures of \$873,451 for the same month. She also reported that as of July 31, the PUD has \$202,618 in grant reimbursements outstanding for ongoing projects. That number dropped significantly as compared to June, with the large FEMA disaster reimbursement received. She also stated that the general cash and investment balance is larger as compared to July 2022 because of that FEMA reimbursement. When August financials are reported, the general cash balance will fall more in line with the typical balance because the FEMA payment will be transferred to the Substation Fund. Katie reviewed the budget to actual report through July 2023 against the annual budgeted and stated that the percentages should be right around 58%, so the revenues and expenditures are tracking as expected.

During the last week of June 2023, a PUD 1 Crew or Crew contracted by the PUD was operating a multi wheel piece of machinery with a brush clearing attachment on the front to clear scotch broom from around the School House Hill Sub Station. I had come home for an early lunch when I heard them working on the west side of the substation. I walked part way up the driveway to check out the commotion. I had to stop in my tracks as when the machine engaged the brush again it sent a shower of rocks, stick and brush pieces across my driveway.

I retreated to my house until the work paused and then drove my Brush engine out quickly before the crew resumed. As I left, I saw them change direction and start to work the section toward my house.

I did not discover the broken window till the weekend when my daughter came to visit as I had been busy with fire department tasks all week and had been using the west entrance to come and go. I also hadn't watered patio plants for a couple days which is on the side of the house where the window was broken. I noticed the break on the weekend and called the PUD after the July 4th holiday and reported the incident.

I have been a little slow getting this done as it is fire season and I have already been on 2 fire mobilizations and numerous other calls.

Trachte, LLC ("Seller") offer to sell or acceptance of an order or line of orders (collectively "Orders") submitted by a customer ("Buyer") for products of Seller (" Products") or services of Seller ("Services") are expressly conditioned upon Buyer's acceptance of these terms and conditions ("Terms"). Seller shall not be bound by the terms and conditions set forth in Buyer's Orders. In the case of discrepancy or conflict between Orders and these Terms, these Terms shall control. Additional or differing terms contained in Orders that are not expressly acknowledged and accepted by Seller are expressly rejected. These Terms shall supersede all prior communications between Seller and Buyer including but not limited to Orders and verbal Quotations and will constitute a binding contract ("Contract") between Buyer and Seller, which can only be modified by mutual written consent of Buyer and Seller. In the event of conflict with the Terms the Seller's written Quotation and Specifications shall take precedence.

**Definitions**:

As used herein, the term "Buyer" shall mean the purchaser of the Products or Services identified on Seller's Quote and Specifications, Contract, or written acknowledgement; the term "Buyer's Customer" shall mean the initial purchaser of the Products and Services from a Buyer that is recognized by Seller to be purchasing such for resale; the term "Products and Services" shall mean all equipment, accessories and any labor and services identified on Seller's Order Acknowledgement, and all attachments, exhibits, amendments and change orders to it; the term "Order" shall mean the terms and conditions described in any Contract and seller's Order Acknowledgement and all attachments, exhibits, amendments and change orders to them, and these Terms & Conditions; the term "Contract" shall mean any written agreement between Seller and Buyer that is applicable to the Order and Product or Services.

Applicable Documents: All of the following documents shall be incorporated into the Contract:

a. "Quote or Quotation" is a Seller document describing Products or Services, sale price and other key terms of the Contract.

"Specifications" is a Seller document that provides additional detail on the Products or Services.

- "Warranty" or "Warranties" are Seller documents that provide detail on the length and nature of Seller's express warranties relating to Products or Services. Only those Warranties identified in a Quote or Specifications shall apply, but if no Warranties are mentioned, then only the "Two-year Standard Limited Warranty" shall apply.
- "Rigging Diagram" is a diagram reflecting location and suggested minimum lift points to avoid the risk of damage to Product during offloading and is not a certified lift plan. This document is provided when Buyer is responsible for offloading and installation of Product. The diagram also includes the Seller's Liability Disclaimer for crane rigging and operations, which applies to specified Contracts and limits Seller's liability relating to the installation of the Product.
- e. "Storage Policy" provides the details, terms and charges when Buyer delay's shipment of completed Products and requests Seller to arrange storage.

Shipment and Provision of Services:

- a. Shipping: Seller will attempt to comply with, but in no case will guarantee, a Product's shipment date or the date for completion of Services. Seller shall have no liability for loss, damage, delays or inability to ship or install Products for reasons beyond its control including, but not limited to: Acts of God; fire; floods; war embargoes; weather; labor disputes; acts of sabotage; riots; accidents; delays of carriers, subcontractors or suppliers; voluntary or mandatory compliance with any governmental act, regulation or request; shortage of labor, materials or manufacturing facilities. Seller reserves the right to prorate shipments against all Orders whenever it believes an oversold situation exists. In the event of default by Buyer, Seller reserves the right to postpone, cancel or deny the provision or sale of Products or Services to Buyer without waiving any of its rights under the Order.
- b. Delivery: Adequate, all-weather site access is required to permit a semi-tractor with trailer and building load and the crane to drive into the site and stage for lift. This requires a suitable site access road and site ground surface, a drive entrance with broad enough radius and approaches without width or height obstructions, i.e. tree branches, buildings, gates, fences, overhead wires, power lines, nearby equipment, pipes or conduit, trenches, berms, etc. If Seller's Quote and Specifications include installation, the crane services are based upon the crane service provider standards for crane size and appropriate site conditions for the lift. Buyer agrees that all charges for additional services, labor, and/or equipment required, including but not limited to: larger crane, multiple cranes, extra rigging, trans-loading of building load to an interim trailer or elsewhere, jack and roll operations, insulation of energized lines, outages, etc. will be passed on to and paid by the Buyer. Unless specified otherwise in the Quote, neither Seller nor crane service provider have visited the site
  - Seller is not responsible for damage to the ground surface, i.e. asphalt, concrete, gravel etc. during placement of the building due to the crane, semi-tractor or trailer.
  - The Buyer or their agent will sign the Bill of Lading upon delivery, indicating acceptance of the building in satisfactory condition. If the Buyer or their agents are not present to sign for the building, the Buyer's acceptance is automatically implied and rights to contest the building condition, at time of delivery, are waived.
- Storage: At Seller's sole discretion, and in accordance with the Seller's Storage Policy, completed buildings may be stored in Seller's yard for a charge, which is based on the size and weight of the building or module (i.e. each split-building section). In addition to monthly storage fees, Buyer agrees to pay all associated costs for lifting, moving, off-site storage, etc. Please contact Seller for availability and cost of storage for a particular building. Seller reserves the right to terminate or refuse storage of any building contingent upon, but not limited to, production space requirements, availability of storage space, or payment of invoices. Regardless of any previous Purchase Order or Contract terms, 90% of the building price will be invoiced and must be paid based upon the ready to ship date. Buyer to contact Seller for availability and cost of storage for a particular building, and Seller will provide Buyer with a Change Order and Request for Storage documents for Buyer to approve and return prior to building storage.

Shipping Charges and Passage of Title:

All Products will ship from the Seller's factory, with the factory shipping location to be designated by Seller. Buyer is solely responsible for payment of freight, duties, handling and cartage and, unless otherwise specified by Buyer, the Seller shall determine method of shipment and other matters relating to shipment. A freight estimate to Buyer's designated location will be provided in Seller's Quotation. Site services, if applicable, will be invoiced separately at time of building delivery.

If Seller arranges delivery, Title to the Product, and all risk of loss or damage to such Product will pass to the Buyer upon delivery to Buyer's location, before installation. If Seller is responsible for installation the risk of loss passes after Product installation. For Buyer's own protection, Seller encourages Buyer to insure the Product for its full replacement value, and to carefully inspect the Product immediately upon receipt. In the event of damage a notice of claim should be filed with the carrier without delay. Such notice should also be given to Seller. In no event shall Seller be deemed to assume any liability in connection with any shipment, nor shall the carrier be construed as an agent of Seller. All claims of loss and damage are to be filed with the carrier and not Seller.

Buyer may arrange for their own building delivery, and Title to the Product, including all risk of loss or damage to Product, will pass to Buyer upon delivery of Product to Carrier.

- a. The final price is to be documented in a written formal Quotation signed by an authorized employee of Seller. In no case will verbal negotiations, quotations; or budgetary quote letters be considered a valid purchase price. In the event of discrepancy between the price on the Buyer's order and Seller's written Quotation, the price on the written Quotation will control. In no case will Buyer's cost to prepare its facilities for the Product or Services be included in the price unless specifically specified in the written Quotation.
- b. Quote & Pricing Validity. Unless specified otherwise therein, Seller's written quotation shall be valid for thirty (30) days from the quotation date. Seller's written Quotation and availability information DO NOT constitute a legal binding offer to sell. Written Quotations beyond the validity date stated therein may be reinstated subject to review of price changes for materials, components or services. Seller shall not be held responsible for price increases for materials, components, services, or foreign exchange rate changes which Seller has no direct control over, and pricing shall be increased accordingly for any Quotation regardless of validity.

Acceptance:

Trachte LLC's acceptance of Buyer's purchase order is expressly made conditional on Buyer's acceptance of Trachte' General Terms and Conditions of Sale, which is in lieu of any additional or different terms contained in Buyer's purchase order or other document or communication pertaining to Buyer's order for the Product, which additional or different terms shall be deemed ineffective. In any event, these actions do not relieve Buyer of any contractual obligations.

#### 10. Taxes, Fees and Permits:

All prices for Products and Services are quoted exclusive of any and all taxes including but not limited to sales, excise, or other governmental or regional tax. Buyer is responsible for payment of taxes which will appear as separate line items on the invoice for the Product or Services except in the case that a valid and appropriate tax exemption certificate is provided to Seller by Buyer prior to shipment of the Product. Prices do not include local fees or building permits, which shall be the responsibility of the Buyer. If a State Approval Seal is included in the Seller specifications, then Seller has included all associated fees for those State Approvals and Inspections.

#### 11. Codes, Site Installation and Site Preparation:

- a. The building is quoted as detailed in the Seller's Building Specification. Seller builds to major National Codes (IBC, UBC, NEC, etc.), however because of local building department jurisdiction, it is the Buyer's responsibility to verify that the specified Seller designed shelter meets LOCAL building codes and requirements. Seller assumes no responsibility or liability for potential delay, rejection, or additional costs arising from Buyer's failure to investigate or secure any required approvals or permits.
- b. If installation is included, Seller agrees to install the Product ready for use on the site designated by Buyer, provided the site has been made to conform to the Site Specification Requirements provided by Seller to Buyer. Seller will have the option to inspect the site prior to installation.
   c. Buyer shall provide all necessary site work for the Product installation including, but not limited to, site preparation and electric service as required to attach and install the Product
- c. Buyer shall provide all necessary site work for the Product installation including, but not limited to, site preparation and electric service as required to attach and install the Product ready for use. Buyer shall obtain all permits and licenses required by federal, state or local authorities in connection with the installation and operation of the Product and shall bear any expense in obtaining the same or in complying with any related rules, regulations, ordinances and statutes.
- d. In the event Buyer's local labor conditions make it impossible or undesirable to use Seller's regular employees for such installation and connection, such work shall be performed by Buyer supplied laborer, or Buyer's choice of independent contractor, at Buyer's expense, and in such case Seller agrees to offer optional pricing to provide adequate site supervision for proper completion of the installation.
- e. If no site services are purchased by Buyer from Seller, Buyer and its contractors shall follow the Rigging Diagram provided by Seller and, shall indemnify Seller from responsibility for personal injury or property damage arising during site installation and, Buyer waives any such claims against Seller.
- f. Arrangements for internal movement of the Product to the final installation location are the responsibility of Buyer.
- g. Buyer assumes all responsibility for Product damage caused by contractors or laborers supplied by Buyer.

#### 2. Buyer Site Acceptance:

Buyer to accept the Product by executing the Seller supplied site acceptance document(s). The acceptance documents are not to be modified or the conditions of sale changed unless mutually agreed upon, in writing, by Buyer and Seller.

#### 13. Insurance:

Seller agrees to maintain Commercial General Liability insurance to protect Buyer in the event of injury or death of any of seller's employees, or other persons, and to comply with the provisions of applicable wage & hour and workers compensation laws.

- a. Seller will maintain the following minimum coverage: Commercial General Liability with limits of not less than \$1,000,000 per Occurrence/\$2,000,000 Aggregate/\$2,000,000 Products & Completed Operations Aggregate; Worker Compensation/Employer Liability limits of not less than \$100,000/\$500,000/\$100,000, Automobile Liability limits of not less than \$1,000,000 Combined Single Limit and Commercial Umbrella limits not less than \$10,000,000.
- b. If Buyer requests Seller to store finished product on behalf of Buyer, Buyer agrees to obtain appropriate property insurance equal to at least 100% of the Product value.
- c. Buyer agrees to either; disclose at time of Quotation the value of Property Buyer ship's to Seller's factory for integration with the Product or; will carry any additional insurance needed to assure coverage in the event of damage or loss in excess of Seller's coverage.

#### 14. <u>LIEN NOTICE</u>:

AS REQUIRED BY CONSTRUCTION LIEN LAW, SELLER NOTIFIES BUYER THAT PERSONS OR COMPANIES FURNISHING LABOR OR MATERIALS FOR THE CONSTRUCTION ON BUYER'S LAND MAY HAVE LIEN RIGHTS ON BUYER'S LAND AND BUILDINGS. IF NOT PAID, THOSE ENTITLED TO LIEN RIGHTS, IN ADDITION TO THE UNDERSIGNED SELLER, ARE THOSE WHO CONTRACT DIRECTLY WITH THE BUYER OR THOSE WHO GIVE THE BUYER NOTICE WITHIN SIXTY (60) DAYS AFTER THEY FURNISH LABOR OR MATERIALS FOR THE CONSTRUCTION. ACCORDINGLY, BUYER WILL PROBABLY RECEIVE NOTICES FROM THOSE WHO FURNISH LABOR OR MATERIALS FOR THE CONSTRUCTION AND SHOULD GIVE A COPY OF EACH NOTICE RECEIVED TO HIS MORTGAGE LENDER, IF ANY, SELLER AGREES TO COOPERATE WITH THE BUYER AND HIS LENDER, IF ANY, TO SEE THAT ALL PERPETUAL LIEN CLAIMANTS ARE DULY PAID.

Upon completion and request from Buyer, Seller agrees to furnish an affidavit that all sub-contractors, laborers and materials have been paid in full.

#### Patents, License to Use:

The sale of the Product extends a right to use the Product. Seller does not warrant and shall not be held liable from any claim unjustified or justified by any third party for the infringement of any patent or copyright by Buyer in the use or ownership of the Product. In the event of alleged infringement, Seller may at its sole discretion request the return of the Product and refund amounts paid by Buyer for such Product minus a reasonable depreciation amount. In no case shall Seller be liable for Buyer's lost production as a result of any infringement.

Seller shall not be liable for; (i) any additions or modifications by Buyer to the Product or; (ii) items or capability added or placed in the Product and; (iii) for any third party infringement arising from Buyer supplied materials or equipment for installation or incorporation with Seller's Product. Buyer shall indemnify and hold Seller harmless from any damages or injury arising from such claims, including, but not limited to, costs and reasonable attorney fees incurred by Seller in defense thereof.

#### **Termination of Contract and Delays**

- Either Party may, without prejudice to any other right or remedy the Party may have herein, terminate the Contract or any portion of a Purchase Order "Termination for Cause" if a Party had filed, or has filed against it, a petition for voluntary or involuntary bankruptcy; pursuant to any other insolvency law, Party makes or seeks to make a general assignment for the benefit of its creditors or applies for, or consent to, the appointment of a trustee, receiver or custodian for a substantial part of its properties; or Party is generally not, or is unable to, or admits in writing its inability to, pay its debts as they become due and payable.
- Buyer may, by written notice to Seller, terminate the Contract in whole or in part, for Buyer's convenience "Termination for Convenience". Upon receipt of written notice of Buyer's intention to terminate the Contract for convenience, or upon notice to Buyer of Seller's intention to terminate the contract for Cause, Seller shall stop work immediately and notify all suppliers and subcontractors to stop work immediately. Buyer will agree to pay Seller for all liabilities and obligations owed to Seller, at the contracted-price for all Work performed and for all Products delivered or then in progress, provided that such payment amount shall not include damages, payment for Products maintained in stock, or any anticipated profits on Products not yet shipped or Work not yet performed. In no event shall Buyer's liability exceed the total Contracted Price of the delivered Products.

Seller, within ten (10) working days of notice of termination, shall provide Buyer with the cost resulting from said termination. Buyer to provide payment of termination cost within fifteen (15) calendar days of presentation of Invoice from Seller, and agrees to take possession and remove all Products from Seller's premises within fifteen (15) calendar days of Seller's receipt of Buyer's payment, or will reimburse Seller for costs incurred to dispose of product.

Seller will publish a schedule at time of order acceptance with key milestones, to which both Buyer and Seller will agree. Buyer recognizes that delays requested or caused by Buyer, related to the milestones will require Seller to change the engineering, raw material procurement and/or production schedule. Such changes may lead to Seller incurring unexpected cost increases related to expediting, overtime, raw material, or other unforeseen items. If Seller incurs or anticipates incurring additional costs due to delays caused by or requested by Buyer, Buyer agrees to accept price increases that result from such schedule changes. Seller agrees to notify Buyer, in writing, at the time of the delay that such delay will cause a price change and provide the amount of the price change as soon as possible following the delay.

#### Warranty of Product:

Seller Warrant's only materials and labor performed by or in direct supervision of authorized Seller personnel.

Buyer acknowledges that Seller Quotation and Specifications may require equipment or material of third parties to be installed or incorporated into the Product. Seller disclaims any warranty arising from defects in customer furnished materials or equipment, or whether specialty or Buyer furnished material or equipment will perform when installed in Seller's Product. Buyer shall release Seller from damages or liability related to such material or equipment.

The Warranty does not extend to any Product which are (a) subject to misuse, neglect, accidents, Acts of God, or causes of a similar nature; (b) repaired or altered by anyone other than Seller, or without Seller's prior approval; (c) improperly installed without the direct supervision of Seller or Seller's authorized Technician; (d) consumable parts or materials. This Warranty does not extend to components which are separately covered by a warranty issued by the respective manufacturer.

#### LIMITATION ON LIABILITIES:

#### **Confidential Information:**

Buyer recognizes that Seller has or will disclose Confidential Information (as defined herein) belonging to Seller or to third parties to whom Seller is under an obligation not to disclose such Confidential Information except to certain authorized parties, such as Buyer. Buyer will use the same standard of care to protect Seller's Confidential Information as it uses to protect its own proprietary information. Buyer shall have no right to copy, reproduce, or disclose Confidential Information to others in whole or in part any of the above without the prior written permission of Seller. This provision shall not supersede any active non-disclosure agreement between Buyer and Seller. As used in these Terms, "Confidential Information" means any of Seller's proprietary information, technical data, or know-how (including, but not limited to, information relating to Products, Product design, Product software, operating manuals, Services, engineering, marketing, Buyer's, pricing, or sales processes) disclosed by Seller to Buyer either directly or indirectly in any form whatsoever (including, but not limited to, in writing, in machine readable or other tangible form, orally or visually)

#### Indemnification from Buyer's Use:

Buyer agrees that the Product will be used for commercial and not consumer purposes. Buyer agrees that the Product purchased hereunder shall be operated exclusively by duly qualified personnel in a safe and reasonable manner in accordance with Seller's written instructions and for the purpose for which the Product was intended, and further, in compliance with applicable government labor and safety standards, etc. Buyer agrees to indemnify and hold Seller harmless from and against all claims, demands, actions, causes or actions, judgments and costs, including reasonable attorney's fees, arising out of or in connection with the operation of the Product by Buyer, unless caused by Seller's gross negligence.

If any Term herein is held invalid, illegal, or unenforceable, the Parties agree that such invalidity shall not affect the validity of the remaining Terms, and the Parties agree to substitute for the invalid portion a valid provision that most closely approximates the economic and intent of the invalid portion.

The contract is governed under the laws of the State of Wisconsin, USA, without reference to conflict of laws principles or to the United Nations Convention on Contracts for the International Sale of Goods. The exclusive jurisdiction and venue with respect to any action arising out of or related to the purchase of the Product or Services shall be in the courts of Dane County, State of Wisconsin, and the parties hereto expressly submit to the jurisdiction of said courts.
