does hereby invite bids from qualified, Agate Beach Water System Improvements Phase 3.

SEALED proposals must be received at the Mason County PUD No. 1 main office located at 21971 North Highway 101, Shelton, WA 98584, by 4:00 P.M. PST on Monday April 8, 2024, be addressed to "Brandy Milroy-Agate Beach Water System Improvements Phase 3" and include amounts for furnishing the necessary labor, materials, equipment, and tools, thereof to construct the Agate Beach Water System Improvements Phase 3 - Booster Pump Equipment/HVAC/and Electrical. Contractor may submit the bid in person at the PUD office between 8:00 a.m. to 5:00 p.m. Monday through Friday. Alternatively, the Contractor may use the PUD drop box located outside the front office. The PUD makes no guarantee that bid packages submitted by mail will arrive prior to the bid deadline. SCOPE OF WORK:

Furnish and install a new packaged booster pump station, HVAC, standby generator, electrical, telemetry, instrumentation, security fencing, and restoration. The Work shall be physically complete within 90 calendar days after the commencement date stated in the Notice to Proceed

All bidding and construction shall be performed in compliance with the Contract Provisions and Contract Plans for this project and any addenda issued thereto that are listed on the PUD's website: https://mason-pud1.org/bids/

PREPARATION AND CONTENT OF THE PROPOSAL:
