- 1. Review the Income Qualifications chart.
- 2. Complete the Income Eligibility form.
- Submit form with one of the listed income verification documents to Cassandra at the PUD 1 office or to <u>CassandraS@mason-pud1.org</u>.
- 4. If you qualify for the rebate, Cassandra will give you a "prequalified" letter to take into South Sound Appliance.
- 5. South Sound Appliance will show you the models eligible for the rebate. There are several to choose from!
- 6. Once you choose your appliances, they will automatically deduct the \$800 for each appliance from your sales price.
- 7. You are responsible for any remaining balance after the \$800, including sales tax, and any delivery and installation fees, if you choose those extra options.
- 8. South Sound Appliance will submit directly to the PUD for the rebate- you don't have to worry about any additional paperwork!

## **INCOME VERIFICATION**

A household may qualify for incentives if it meets at least one of the following criteria listed in Table 1 below. You may provide proof of income either by providing verifiable documentation to your utility or to the Community Action Agency.

Gross income includes all wages, tips, rental income, public assistance, social security or pensions, income from self-employment, alimony, interest, or any other sources of income defined by the IRS income tax return.
