Description of proposal – The project proposes to construct two 200,000 gallon reservoirs and a booster pump station on PUD-owned property. Construction will include site preparation and restoration as well as the installation of telemetry, on-site piping, fencing, and emergency power generation. One reservoir will serve the Highland Park distribution system and one reservoir will serve the Alderbrook distribution system. The booster pump station will initially serve the Highland Pressure Zone. Future pumps will serve the Alderbrook Pressure Zone.

Location of proposal – 1681 E McReavy Rd, Union, Washington 98592, which is accessible via State Route 106.

Mason County PUD No. 1 has determined that this proposal will not have a probable significant adverse impact on the environment.
