Description of proposal – The project includes the construction of a new 257 square foot filter building, a new 6,460-gallon infiltration pond, new site piping, the construction and installation of a new pyrolusite filtration system and new sodium hypochlorite feed system, electrical and control modifications, and site improvements. This project will also replace the existing wellhouse's roof and construct site fencing and gates.

Location of proposal – The project is located on parcel 319013360250 which is on the Southeast corner of the intersection of SE Sells Drive and SE Bay East Drive.

Mason County PUD No. 1 has determined that this proposal will not have a probable significant adverse impact on the environment.
