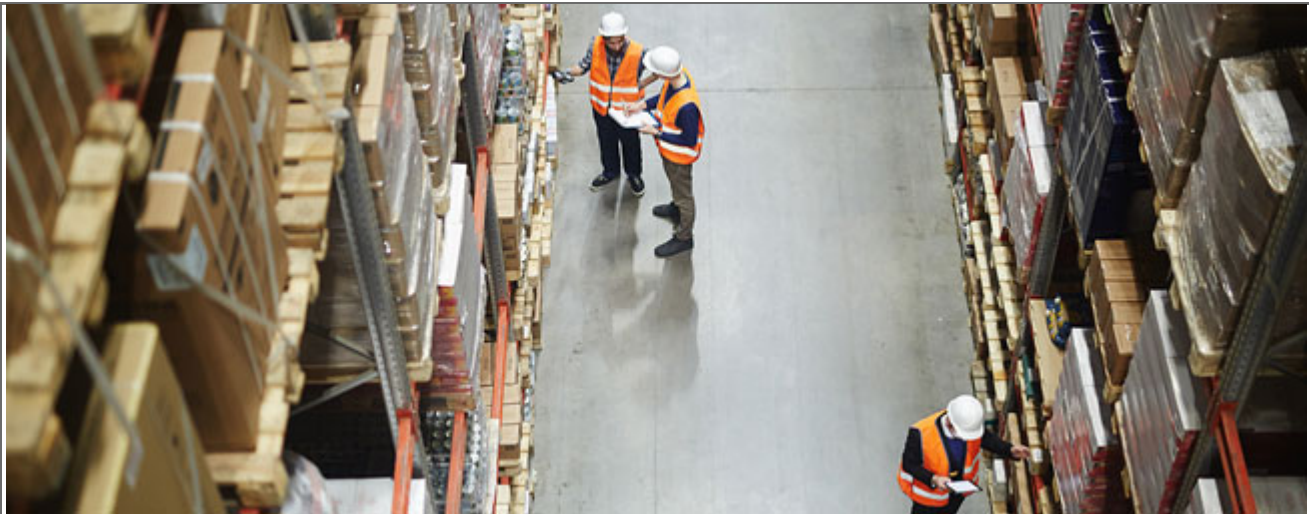

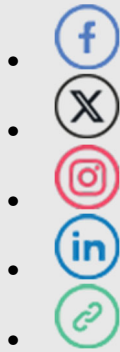

## FY27 Funding Applications Opening Soon

Applications to the PWB FY27 funding cycle open on June 1, 2026. The PWB will award up to \$202 million for construction, \$20 million for pre-construction, and \$7.5 million for emergency projects. ## PWB Awards \$6.6 Million for Pre-construction and Emergency Projects

During the May board meeting, the PWB awarded close to \$6.4 million to 10 pre-construction projects across Benton, Grant, Kitsap, Kittitas, King, Snohomish, Spokane, Walla Walla, and Yakima counties. An additional \$277,500 was awarded to the City of Bridgeport for emergency repairs of a water transmission main which suffered multiple breaches between March and April this year.

This PWB-funded project will provide reliable power and water infrastructure for the Union area for years to come.

## Featured Project of the Month

### Reservoir Recoating Project | Domestic Water | Vera Water and Power

The Reservoir Recoating project recently completed repairs and recoating of three water reservoirs serving communities in Spokane Valley. The project received a construction award from the PWB in 2024 to protect the reservoirs from corrosion. Taking proactive measures to extend the useful life of the reservoirs helps save future costs given that the price of replacing corroded reservoirs would be almost four times as expensive as periodically recoating the reservoirs instead. This project preserves a major infrastructure asset serving Spokane Valley, helps keep utility bills affordable for Vera Water and Power customers, and achieves public health and safety goals for the community.
